**SUBJECT: A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF CHEVY CHASE MARYLAND, ADOPTING THE MONTGOMERY COUNTY MULTI-HAZARD MITIGATION PLAN, AS REQUIRED BY TITLE 44 CODE OF FEDERAL REGULATIONS PART 201 AS AUTHORIZED BY THE DISASTER MITIGATION ACT OF 2000, IN ORDER TO REMAIN ELIGIBLE FOR STATE AND FEDERAL DISASTER RELIEF FUNDING.**

WHEREAS, an adopted all hazards mitigation plan is required as a condition of future grant funding for mitigation projects;

WHEREAS, the Town of Chevy Chase participated in the planning process with the County to prepare a Multi-Hazard Mitigation Plan;


NOW, therefore, be it resolved that the Town of Chevy Chase Council, hereby adopts the Montgomery County Multi-Hazard Mitigation Plan, and

The Town of Chevy Chase will continue to participate in the updating and expansion of the Montgomery County Multi-Hazard Mitigation Plan in future years, and

The Town of Chevy Chase will further seek to encourage the businesses, industries and community groups operating within and/or for the benefit of the Town of Chevy Chase to also participate in the updating and expansion of the Montgomery County Multi-Hazard Mitigation Plan.
