**RESOLUTION OF  
THE TOWN OF CHEVY CHASE**

**SUBJECT: Resolution to Amend Permit and Performance Bond Fees**

**WHEREAS**, Section 5-205 of the Local Government Article of the Maryland Code authorizes municipal corporations within the State to establish and collect reasonable fees and charges for the franchises, licenses or permits authorized by law to be granted by a municipal corporation, or associated with the exercise of any governmental or proprietary function authorized by law to be exercised by a municipal corporation; and

**WHEREAS**, Section 4-2(k) of the Town Code authorizes permit fees to be established by resolution of the Town Council; and

**WHEREAS**, the Town Council finds that modifying the fee schedule with respect to applications for permits and variances, as set forth in this Resolution, would promote the good government of the Town and protect and preserve the Town's rights, property and privileges.

**NOW, THEREFORE**, it is, on this date of January 14, 2015 by the Town Council of the Town of Chevy Chase:

**RESOLVED**, that the permit and variance fee schedule for the Town is amended to read as follows:
