Message from Mayor Scott Fosler

Spring is a particularly busy time in the Town, and especially so this year.

Budget

At its April 17 meeting, the Town Council will hold another public comment period on the Town's fiscal year 2018 budget. And at the May 2 annual Town meeting, the Council will hold a public hearing before adopting a final budget for next year.

Budget information will be included in the Town's special election issue of the Forecast newsletter, which will be delivered to each home in Town by April 18. Detailed budget documents will be available on the Town website for review. I encourage everyone to provide the Council with your comments and suggestions about programs and services you would like to see added, increased, trimmed, eliminated or otherwise modified. You may attend the public meetings to provide your thoughts, or you may submit comments by mail or email. All communications will be reviewed and considered by the Council.

Election

The Town's election, as well as the annual meeting, will be held on May 2. Town residents will select two candidates in the 2017 election, each to serve for a two-year term. Nominating petitions for those who would like to run as candidates for the Council and have their names appear on the printed ballot are due by 5 p.m. on April 11. Those who would like to run as write-in candidates and be eligible to serve on the Council must file a certificate of candidacy by 5 p.m. on April 25. To be eligible to serve on the Council, both balloted and write-in candidates also must submit financial disclosure forms with their respective candidate filings.

A Candidates' Forum will be held on April 26 at 7 p.m. in the Town Hall to allow residents to meet and converse with those running for the Town Council. I hope that all of you will participate in our annual election of Councilmembers and attend our annual meeting, which will include a presentation by Senator Rich Madaleno and a report on the Town's activities and accomplishments over the past year.

Bethesda Downtown Plan

The County Council's Committee on Planning, Housing and Economic Development (PHED) is completing its review of the draft Bethesda Downtown Plan (BDP) and could well make its recommendations to the full Council within the next few weeks. The Town Council, Special Committee on the BDP, Coalition of Bethesda Area Residents (CBAR) and many other Town residents and neighbors are energetically engaged with County Councilmembers as we move to the climax of this long process, which will impact our community for the next several decades. We will continue to keep you up-to-date on fast-breaking developments through the Forecast and Town Crier.

Public Meeting on Town Parking Regulations

On Monday, April 24 at 7 p.m. in the Town Hall, the Town's Public Services Committee will hold a meeting for all Town residents to discuss parking in the Town. Resident input is essential in planning for the impact on Town parking of current and future development in downtown Bethesda. The goal of the meeting is to gather information and obtain resident feedback on the current parking and permit policies and is not to resolve specific resident parking situations. Topics of discussion will include:

- Parking enforcement: Should current parking restrictions be more strictly enforced? Is the current visitor parking pass system adequate for the needs of residents on streets with permit parking?
- Parking restrictions: Will more streets need to have permit parking as development continues? Should there be a change in the hours when permit parking is in effect?
- Zoned parking: Should the Town implement permit parking zones so that those with permits may only park in designated areas near their homes?

TOWN UPDATES

Clear Vegetation from Sidewalks

As a reminder, residents are asked to keep all sidewalks clear from edge to edge up to a height of 7 feet. The Town's maintenance standards for vegetation installed by Town residents on public and private property are available on the Town website. Thank you for your cooperation in helping to keep Town sidewalks safe.

Reminder About Permit and Restricted Parking

Residents are reminded that it is illegal to park in areas designated as "No Parking" zones, including those adjacent to and across from St. John's Church. Residents also are reminded that parking permits are intended for vehicles parked within the vicinity of your address only.

No Parking on Grass or Sidewalks

We want to remind residents that the Town prohibits parking any vehicle on the grass area between the curb and/or gutter and sidewalk, or parking on any sidewalk. Also, the County Code, which is applicable in the Town, prohibits parking opposite to the flow of traffic (left wheels to curb). Please be courteous to your neighbors by observing these rules.

Any information you can give to the police will help to make us safer. Any older adult in the area can request a home inspection with a fire-fighter and one of our volunteers to update smoke and carbon monoxide alarms and to check general home safety issues. TRASH & TREASURES

The Town's spring Trash and Treasures is scheduled for the weekend of [April 22 & 23](#). The Town offers this bulk trash pickup so that residents can dispose of items that are no longer usable, such as appliances (doors must be removed for safety), furniture, rolled rugs, mattresses, games and bikes. If the items are usable, we encourage you to review the list of [Alternatives to Trash and Treasures](#) (see reverse). We have tried to give you a variety of options.

GUIDELINES

- Please remember to bag, box or contain all of your discards.
- Please do not put items on the curb before Friday afternoon, April 21.
- The following items will not be picked up:
 - NO construction debris
 - NO parts of junked automobiles (engines, transmissions), boats or trailers
 - NO loose glass of any kind
 - NO firewood or fencing of any kind
 - NO paint cans
 - NO flammable or hazardous liquids or solids
 - NO recyclable items, such as newspapers, mixed paper or cardboard, landscape pots, old books and magazines, large plastic bins - please recycle!
 - NO shrubbery cuttings, yard clippings, leaves or grass – recycle with yard trash!

If you have questions about how to discard any of these items, please call the Town Office at [301-654-7144](#). We will be happy to help you arrange a special pick-up for items that are not included in Trash and Treasures. There is a charge for a special pickup.

PICK UP SCHEDULE: At 7 a.m., [Monday, April 24](#), a crew will begin clearing feeder streets to Chevy Chase Elementary School. During non-rush hours, the peripheral streets will be cleared. After these priority streets are cleared, the truck will proceed according to a pre-arranged schedule. Once a street has been cleared, the contractor will *not* return to that street. Residents who discard items after the street has been cleared will have to arrange for a special pick-up.

Hazardous Waste Disposal

The Household Hazardous Waste receiving area at the Shady Grove Solid Waste Transfer Station is located in the recycling drop-off section of the Public Unloading Area, 16101 Frederick Rd, Derwood, MD 20855. Please use the car entrance to the facility. The drop-off is open Monday - Friday, 7 a.m. to 8 p.m.; Saturday, 7 a.m. to 5 p.m. and Sunday, 9 a.m. to 5 p.m. Household Hazardous Waste can only be received during these hours -- please do not drop off this material at other times. Batteries are accepted (alkaline batteries may be put in regular trash) as are fertilizers with herbicides; fluorescent light tubes and bulbs, including CFLs; herbicides; insecticides; mercury containing items; oil-based paints; paint thinners; pesticides; and used motor oil and most other oils. Donate Books
