Subject: AN ORDINANCE TO ADD AND REMOVE TREE SPECIES FROM

THE LIST OF CANOPY TREES IN THE URBAN FOREST

ORDINANCE

WHEREAS, Maryland Code, Local Government Article, Section 5-202, as amended, grants to the legislative body of every incorporated municipality in Maryland general power to pass such ordinances not contrary to the Constitution of Maryland, or the public general law, as deemed necessary in order to assure the good government of the municipality, to protect and preserve the municipality's rights, property, and privileges, to preserve peace and good order, to secure persons and property from danger and destruction, and to protect the health, comfort and convenience of the citizens of the municipality;

WHEREAS, the Natural Resources Article, Title 5, Subtitle 4, Part IV of the Maryland Code authorizes a municipal corporation to implement a local urban and community forestry program within its jurisdiction; and

WHEREAS, Section 301 of the Town of Chevy Chase Charter authorizes the Town Council to pass ordinances as it may deem necessary for the good government of the Town and for the protection and promotion of the health, safety, comfort, convenience, and welfare of the residents of the Town; and for such other police and health matters as it may deem necessary; and

WHEREAS, trees benefit the Town by filtering the air, capturing carbon dioxide, providing shade, buffering noise, harboring wildlife, controlling storm water runoff, and stabilizing soils, and the Town Council has determined that certain trees in the Town constitute an important natural resource that must be protected, preserved, and replaced; and

WHEREAS, after receiving a recommendation from the Canopy Tree Working Group and upon consideration of the testimony and evidence presented at the public hearing, the Town Council finds that the ordinance as hereinafter set forth is necessary for the good government of the Town and for the protection and promotion of the health, safety, comfort, convenience, and welfare of the residents of the Town.

Sec. 29-3. - Trees included.

- (a) This chapter applies to the following trees on private and public property in the Town of Chevy Chase:

AN ORDINANCE TO MAKE COUNTY CODE CHAPTER 33B, CONCERNING PESTICIDES, APPLICABLE IN THE TOWN OF CHEVY CHASE, AND TO CLARIFY THE CODE CONCERNING THE APPLICABILITY OF OTHER CHAPTERS OF THE COUNTY CODE

WHEREAS, Maryland Code, Local Government Article, Section 5-202, as amended, grants to the legislative body of every incorporated municipality in Maryland general power to pass such ordinances not contrary to the Constitution of Maryland, or the public general law, as deemed necessary in order to assure the good government of the municipality, to protect and preserve the municipality's rights, property, and privileges, to preserve peace and good order, to secure persons and property from danger and destruction, and to protect the health, comfort and convenience of the citizens of the municipality;

WHEREAS, Local Government Article, Section 4-111 of the Maryland Code authorizes a municipal corporation within the State, by charter amendment or ordinance, to determine what county legislation is applicable within the boundaries of the municipal corporation;

WHEREAS, Section 301 of the Town of Chevy Chase Charter authorizes the Town Council to pass ordinances as it may deem necessary for the good government of the Town and for the protection and promotion of the health, safety, comfort, convenience, and welfare of the residents of the Town; and for such other police and health matters as it may deem necessary; and

WHEREAS, Montgomery County, Maryland adopted 2015 L.M.C., ch. 46 (Bill 52-14) to minimize the potential pesticide hazard to people and the environment, consistent with the public interest in the benefits derived from the safe use and application of pesticides, among other purposes, and although enforcement of the law was enjoined as preempted by, and in conflict with, State pesticide law in *Complete Lawn Care, Inc., et al. v. Montgomery County, Md.* (Cir. Ct. Mont. Cnty. Aug. 3, 2017; Nos. 427200V & 427253V), the law was been upheld by the Court of Special Appeals, on appeal, 240 Md.App. 664 (2019);

WHEREAS, after proper notice to the public, the Town Council introduced the following Ordinance in public session assembled on the 9th day of September, 2021; and

WHEREAS, after receiving a recommendation from the Town Climate & Environment Committee and upon consideration of the testimony and evidence presented at the public hearing, the Town Council finds that the ordinance as hereinafter set forth is necessary for the good government of the Town and for the protection and promotion of the health, safety, comfort, convenience, and welfare of the residents of the Town.

SECTION 1. BE IT ORDAINED AND ORDERED, this ____ day of _____, 2021, by the Town Council of the Town of Chevy Chase, acting under and by virtue of the aforementioned authority, that the Code of Ordinances is hereby amended as follows:

Sec. 1-7. - Applicability of county legislation within town.

- (a) Except as provided in this section, the town council exempts the town from all legislation heretofore or hereafter enacted by the county, relating to any subject upon which the town council has heretofore or is hereafter granted legislative authority either by public general law or by the town charter.
- (b) Subsection (a) of this section does not repeal or prohibit any town ordinance that specifically adopts or incorporates by reference any county legislation, and such county legislation adopted or incorporated as of the adoption of this section or incorporated by references into this Code in the future shall have full force and effect to the extent provided in the town ordinance adopting or incorporating the same.
- (c) The following chapters of the Montgomery County Code, 1984, or portions thereof, enacted by the county, as they now exist, are exceptions to the general exemption set forth in subsection (a) of this section and shall be applicable within the town until such time as the town council shall exempt the town from their application:

- (32) Chapter 32, entitled "Offenses—Miscellaneous."
- (33) Chapter 33A, entitled "Planning Procedures."

(34) Chapter 33B, entitled "Pesticides."

(34)(35) Chapter 34, entitled "Plumbing and Gas Fitting."

(d) Any amendment to the provisions and chapters specified in subsection (c) of this section or the enactment of new chapters to the Montgomery County Code after June 11, 1988 concerning the same subject matter, shall be applicable within the corporate boundaries of the town until the town council adopts an ordinance which exempts such amendment or new chapter within the corporate boundaries of the town. (e) The county is requested to enforce the chapters described in subsection (c) of this section within the town as county laws to the same extent and in the same manner that such county laws are enforced in unincorporated areas of the county. 

At the October 13 meeting, the Town Council will hold a public hearing on a request to install a speed hump in the 7500 block of Maple Avenue. The hump was requested by petition of residents in accordance with the Town's Speed Hump Policy.

Following receipt of the petition, the Town engineer evaluated the street segment and found that there is a feasible location for the speed hump to be installed (to the right of the driveway for 7504 Maple Avenue). The Town commissioned a traffic study to determine whether the speed and volume of traffic on that block meet the Town's qualifying thresholds for a speed hump in that location. According to the policy, the street segment in question must generally meet either of the following criteria to qualify for the installation of the speed hump:

- A minimum of 120 vehicles per day exceeding 25 mph, or
- A minimum of 20 vehicles exceeding 25 mph in any hour of the day.

The traffic study showed that an average of 165 vehicles exceeded 25 mph in a day (236 on the peak volume day), and an average of 19.4 vehicles exceeded 25 mph in the highest volume hour of the day (35 on the peak volume day), so the location qualifies for a speed hump based on the traffic analysis.

Dear Council members,

Thank you very much for considering our proposal for funding from the Town of Chevy Chase's ARPA funds. Wonders Early Learning + Extended Day requests \$125,000, to be used during our current fiscal year, ending August 31, 2022.

The Town residents will benefit from the award of these funds by ensuring the continuity and availability of nonprofit, high quality early learning and extended day programming within the Town's boundaries. Between the two programs, Wonders is providing care and education for children from 18 months to 12 years of age. The continuum of care that Wonders offers beginning at Leland and progressing to Chevy Chase Extended Day, provides families who live in the Town access to age appropriate social/emotional learning as well as cognitive and skill development for their children while also accommodating the schedules of working parents. The work of Wonders supports today's workforce while educating and caring for tomorrow's workforce.

COVID-19 had a significant negative economic impact on our nonprofit organization. The initial shutdown, followed by restricted enrollment capacities, and now the resumption of "normal" operations amid the spread of the Delta variant have all impacted our tuition revenue, which typically comprises 99% of our revenue. Our current enrollment is 75% of capacity at Leland and 33% of capacity at Chevy Chase Extended Day. It will take more than one year to build enrollment to meet our licensed capacity level at both programs.

The combined income loss projected for Leland and Chevy Chase Extended Day is \$125,000. This equals the amount of our request.

In addition to this request, Wonders has applied to the state for a child care stabilization grant, which will be used to support and enhance the professional development of our workforce, which has provided essential services throughout the pandemic. Grant amounts are based on a formula that reflects licensed capacity. Wonders is conducting its annual giving campaign, which will provide nondedicated funding to Wonders.

Wonders provides critical economic infrastructure to the Town through our high quality programs. Families are able to work while their children learn and grow in a safe and caring environment.
