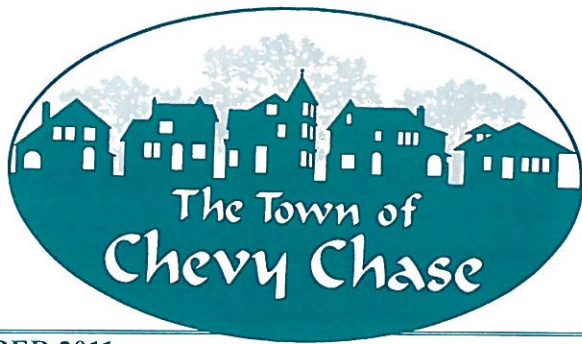

Prevent Crime in Our Neighborhood

Sergeant John D'Albora, Guest Speaker

As part of the Neighborhood Watch Program, the Town will host a Public Safety Meeting on **Tuesday, October 18** at 7 p.m. in the Town Hall. All interested residents are invited to attend to learn more about how to prevent crime in our neighborhood.

Sgt. John D'Albora, who manages the off-duty County officers who patrol the Town, will be the guest speaker. Sgt. D'Albora has been with the Montgomery County Police Department for 24 years, serving in Bethesda for 17 of those years. He will address ways to protect your property from theft and reduce the risk of being victimized. He also will explain how to recognize and report suspicious activities.

Public Hearing

Proposed Amendments to the Building Ordinance

At its **Wednesday, November 9** meeting, the Town Council will hold a public hearing on proposed amendments to the Town's Building Ordinance as recommended by the Town's Land Use Committee. The proposed changes to the ordinance are intended to relax some permitting requirements, to allow accommodations for handicap accessibility, to codify existing practices and to clarify some existing provisions.

A summary of the proposed changes to the building ordinance appears on page 4. The full text of the proposed amended ordinance is posted on the Town's website.

Native Canopy Tree Planting Program

To participate in the Town's Native Canopy Tree Planting Program in fiscal year 2011-2012, just fill out an application form and submit it to the Town. There are application forms on the Town website or in the Town Office.

Under this program, the Town will purchase canopy trees, pay for the service to plant the trees on the homeowner's property, and provide a water bag to assist with the care needed in the critical first year after planting. The resident will be responsible for the long-term care of the tree once the Town plants it.

Energy Tip of the Month

Here's a great science project for kids: use a Kill-a-Watt meter to measure how much energy appliances are drawing even when they're not "on". You can borrow a Kill-a-Watt from the Town office or the Library, plug it in, and check the display after a day. You'd be surprised how much energy these appliances draw. The average Marylander loses \$185 per year from electronic devices that are plugged in even when they're off. Anything that has a light, a clock, or is at all warm is wasting energy. Why not unplug those energy vampires? Plug them into power strips (a few dollars at hardware stores) to make it easy to turn the power off. There's even a "smart strip" that detects when your computer is off and turns off the peripherals.



Energy Trailblazers of the Month

Joe Gitchell and Elizabeth Mumford. How do two working parents with two young children manage to do so much to save energy? They take it on as a family challenge and rely on neighbors for suggestions and inspiration. They have reduced their natural gas consumption by almost 10% between 2008 and 2011 so that it is now 60% of the household gas consumption of the average home in Town. Joe says this is due to the attic insulation they installed with support from the Town's Energy Audit and Improvements Program. They have cut the electricity they draw from PEPCO by 58%; some of that savings is due to solar energy, some due to energy efficiency, and some due to lifestyle changes they have made. Proposed Amendments to the Building Ordinance

Public Hearing on November 9

- The proposed ordinance would allow for the construction of handicap access ramps and wheelchair lifts within a property's building setbacks. The existing building code does not regulate ramps and lifts, so a resident currently must obtain a variance to build these structures within a setback. This process can be costly and time-consuming.
- The requirement to obtain a boundary survey and an established building line survey for certain front porch coverings is proposed to be waived if an applicant has another reliable survey that shows the house is at least 25' from the front lot line. This change would reduce the financial burden of obtaining costly surveys for these smaller projects.
- The proposed ordinance clarifies an existing regulation that allows certain additions to be constructed onto houses that do not conform to current setbacks. The amendment explains that for certain additions, the side setback is to be measured from the location of the addition rather than from the existing non-conforming house. This provision makes it easier for residents to add on to existing, older homes.
- New provisions would be added to codify the Town's existing practice of allowing guardrails and handrails for safety. Under the current code, it is unclear whether these structures should be subject to the zoning restrictions for fences. This proposed change follows the County approach.
- The proposed ordinance clarifies how wall planes are measured to satisfy the offset requirement for front-loading garages. The current building code requires front-loading garages to be offset from walls on either side by 3 feet. The proposed amendment clarifies that this offset must extend from the finished grade to the roofline.
- The portion of the building code regarding structures, fences, walls, hedges, berms, etc., on private property has been reorganized and revised to make it easier to follow and to clarify some provisions.
- A new restriction prohibiting the construction of a wall or berm more than one-foot high within two feet of a side or rear property line is proposed.
- Finally, new definitions have been added to support the new provisions and amendments.

Council To Consider Permit Parking Request

The Town Council will hold a public hearing at its **Wednesday, October 12** meeting to consider a request to designate permit parking in front of 4001, 4002, 4003, 4004 and 4006 Rosemary Street. The parking restriction would be in effect from 7 a.m. to 7 p.m. weekdays and is intended to provide relief to residents from parking problems close to Chevy Chase Elementary School.

Public Hearing At its September 14 meeting, the Town Council decided to survey all residents in the 3900 and 4000 blocks of Rosemary Street to determine support for this request. The results of this survey and of the required vehicle counts, which determine the number of non-resident vehicles parked in the proposed permit area, will be considered by Council in determining whether to grant this request.

Proposed Policy for Considering Requests for New Street Lights

The Town Council will hold a public hearing at its **Wednesday, October 12** meeting on a proposed policy for considering requests for new street lights. The full text of the proposed policy is posted on the Town's website, www.townofchevy Chase.org, and available in the Town Office.

Public Hearing At the September 14 Council meeting, the Public Services Committee presented the proposed policy, which outlines who may make requests for new streetlights and how those requests are processed by Town staff and considered by the Town Council. The Council discussed the policy and agreed with the PSC's proposal to move forward with installing new lights primarily in locations identified as dark areas by the recent street light evaluation study. Because the Town must pay Pepco for any new lights and also pay to maintain them on an ongoing basis, the Council established a budget of \$20,000 for new street lights for this fiscal year. This amount will allow the Town to purchase and install approximately 10 new street lights over the next 8 months.

In the longer term, the Town may consider alternatives such as purchasing the street light network from Pepco. The Council also has asked the Public Services Committee to evaluate opportunities to implement alternative lighting technologies, such as LED, that save energy and money over the long term. At the current time, Pepco does not use LED lights, and it would take much of the Town's reserves to purchase the Town's street lights from Pepco with the Town receiving a possible return on this investment only over the long term.

Leaf Vacuuming Begins in October

The Town will begin vacuuming leaves in mid-October and continue until mid-December. Vacuum trucks pick up continuously, street by street. A map detailing the schedule of the pickup is provided on the Town's website. All leaves should be raked to the curb. Do not rake your leaves into the street. Please make sure that your leaves are not contaminated by cans, sticks, bottles or rocks. The Town has set October 17 as the start date. If there are not a significant number of leaves down by that date, the Town will notify residents of a new start date. The schedule will be posted on the Town website and distributed to residents via the "Town Crier" listserv.
